

NOTICE OF BID

Bids are requested for **MED-CR2-2.56**, the resurfacing of Medina Line Road from Greenwich Road to Ridgewood Road as detailed in the Bid Documents.

Paper copies of the Bid Documents can be obtained at the Office of the Medina County Engineer, 791 West Smith Road, Medina, Ohio, 44256, between the hours of 8:00 AM and 4:30 PM, Monday through Friday. A nonrefundable fee of **\$25.00** will be charged for each set of Bid Documents. Checks shall be made payable to "Medina County Engineer". Electronic copies of the Bid Documents can be obtained from the Medina County Engineer web page at www.highwayengineer.co.medina.oh.us free of charge.

All bids will be accepted no later than **April 9, 2020** at 1:30 PM, Ohio Time, in the Office of the Medina County Engineer, 791 West Smith Road, Medina, Ohio 44256, at which time all properly filed bids will be publicly opened and tabulated.

Bids must be submitted on forms provided by the County and filed in a sealed envelope clearly marked "**MED-CR2-2.56**" by the time and date set forth above. The Engineer's estimate is **\$2,151,184.75**. No contract shall be awarded at a price more than ten percent in excess of the Engineer's estimate.

The Contractor will not be permitted to begin work prior to **JUNE 8, 2020** and all Work shall be completed no later than **SEPTEMBER 11, 2020**.

Each bidder shall be required to file a bid guaranty with the bid in the form of either: (1) a Bid/Performance Bond in the amount of one-hundred percent (100%) of the amount bid; or (2) a certified check, cashier's check or letter of credit in an amount equal to ten percent (10%) of the amount bid, conditioned that the bidder shall, if his bid is accepted, execute a contract in conformity with the bid, plans, details, specifications and bills of material. A letter of credit shall be revocable only at the option of the County.

Only ODOT pre-qualified contractors are eligible to submit bids for this project. Pre-qualification status must be in force at the time of bid, at the time of award, and throughout the life of the construction contract.

Contractor compliance with the equal employment opportunity requirements detailed in the Bid Documents shall be required.

All bidders must comply with the Disadvantaged Business Enterprise Utilization requirements that apply to this contract. The requirements are detailed in item 24 of ODOT's LPA Template - Required Contract Provisions included in the Bid Documents. Reference:

24. PN 013 – 03/15/2019 - DISADVANTAGED BUSINESS ENTERPRISE (DBE) UTILIZATION PLAN AND GOOD FAITH EFFORTS

Contractors and Subcontractors must comply with the prevailing wage rates requirements detailed in the Bid Documents.

The bid will be awarded to the lowest and best bidder. The Medina County Board of Commissioners reserve the right to reject any and all bids.
