

NOTICE OF BID

Bids are requested for: **“T.H. 85 BALLASH ROAD CULVERT NO. 31 REPLACEMENT OPWC PROJECT NO. DIAC04 RE-BID”** in Lafayette Township, in Medina County, Ohio. Said improvement will involve the removal of the existing 96” diameter culvert and installation of a new 96” diameter 10 Gauge Aluminized culvert, including premium bedding & backfill, full-height cast-in-place headwalls, footers, ditching, re-establishment of field drive with culvert pipe, guardrail, asphalt pavement, channel realignment and general excavation, fine grading, restoration and stipulated traffic control in accordance with the specifications and accompanying construction drawings to all aspects of the improvement. The road shall be closed for a maximum of 45 calendar days.

All bids must be submitted electronically through the www.bidexpress.com web service no later than **Monday, June 29, 2026, at 1:00 pm.**, Ohio Time, at which time all bids will be received and read aloud for the project known as **T.H. 85 BALLASH ROAD CULVERT NO. 31 REPLACEMENT OPWC PROJECT NO. DIAC04 RE-BID**.

The Engineer's Estimate is **\$140,750.00**. No contract shall be awarded at a price more than ten percent in excess of the Engineer's Estimate.

Work shall be completed no later than **October 16, 2026**.

Each bidder shall be required to file a bid guaranty with the bid in the form of either: (1) a Bid/Performance Bond in the amount of one-hundred percent (100%) of the amount bid; or (2) a Certified Check, Cashier's Check or Letter of Credit shall equal to 10% of the amount bid, conditioned that the bidder shall, if his bid is accepted, execute a contract in conformity with the bid, plans, details, specifications and bills of material. A Letter of Credit shall be revocable only at the option of Lafayette Township.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contract compliance with the Equal Opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and the Governor's Executive Order 84-9 shall be required.

Bidders must comply with Prevailing Wage Rates on public improvements in Medina County, Ohio as determined by the Ohio Department of Commerce, Division of Labor and Worker Safety and as detailed in the Bid Documents.

The bid will be awarded to the lowest and best bidder. The Board of Lafayette Township Trustees reserve the right to reject any and all bids.
