

## NOTICE OF BID

Bids are requested for the 2024 Friendsville Road Improvement Project OPWC No. DIAA02 which includes the resurfacing of C.H. 35 Friendsville Road (3.86 miles), the resurfacing of T.H. 72 Buffham Road (0.37 miles), and the vertical realignment of C.H. 97 Greenwich Road (230 feet) in Lafayette and Westfield Townships, Medina County, Ohio as detailed in the Bid Documents.

The bid notice can be obtained from the Medina County Engineer web page at [www.highwayengineer.co.medina.oh.us](http://www.highwayengineer.co.medina.oh.us).

All bids must be submitted electronically through the [www.bidexpress.com](http://www.bidexpress.com) web service no later than December 19, 2023, at 1:30 pm., Ohio Time, at which time all bids will be received and read aloud for the project known as **2024 Friendsville Road Improvement Project OPWC No. DIAA02**.

The Engineer's Estimate for is **\$1,163,697.05**. No contract shall be awarded at a price more than ten percent in excess of the Engineer's estimate. All proposals must be submitted electronically through web service at [www.bidexpress.com](http://www.bidexpress.com).

All resurfacing has a substantial completion date of August 2<sup>nd</sup>, 2024. The improvement project will have a final completion date of August 23<sup>rd</sup>, 2024.

Each bidder must file a bid guaranty with the bid in the form of either: (1) a Bid/Performance Bond in the amount of one-hundred percent (100%) of the amount bid; or (2) a Certified Check, Cashier's Check or Letter of Credit must equal to 10% of the amount bid, conditioned that the bidder will, if his bid is accepted, execute a contract in conformity with the bid, plans, details, specifications and bills of material. A Letter of Credit shall be revocable only at the option of the County.

Only ODOT pre-qualified contractors are eligible to submit bids for this project. Pre-qualification status must be in force at the time of bid, at the time of award, and throughout the life of the construction contract.

Contractor compliance with the equal employment opportunity requirements detailed in the Bid Documents must be required.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contract compliance with the Equal Opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and the Governor's Executive Order 84-9 must be required.

Contractors and subcontractors must comply with Prevailing Wage Rate requirements detailed in the Bid Documents.

The bid will be awarded to the lowest and best bidder. The Medina County Commissioners reserve the right to reject any and all bids.
